

STN® Login IDs for Shared Projects Request Form

Terms and Conditions of STN Login IDs for Shared Projects

1. Only full-access STN Login ID holders can request STN Login IDs for Shared Projects. There is no fee associated with acquiring STN Login IDs for Shared Projects.

All STN Login IDs for Shared Projects and passwords will be provided to the full-access STN Login ID holder (Requester) for distribution. STN Login IDs for Shared Projects will automatically allow access to both STN® AnaVist™ and STN® Viewer™ unless Requester specifically requests otherwise.

2. Because shared projects are associated with individual Login IDs, each Shared Project user must have his/her own STN Login ID for Shared Projects. Sharing of Login IDs is prohibited.

3. Full-access STN Login ID holders are responsible for informing STN Login ID for Shared Projects holders of STN Terms and Conditions of usage, as well as database usage policies and restrictions. The Requester can refer STN Login IDs for Shared Projects holders to www.cas.org/legal/infopolicy.html for CAS Information Use Policies as well as to their service center's web site (www.cas.org for STN-Columbus customers, www.stn-international.com for STN-Karlsruhe customers, and www.jaici.or.jp for STN-Tokyo customers).

4. Certain fee-generating activities can be performed by holders of STN Login IDs for Shared Projects. All fees associated with usage by STN Login IDs for Shared Projects holders will be included on the invoice to which Requester's usage is billed.

a. In STN AnaVist, these activities include the ability to Display, Print, and Save documents and use document delivery services.

b. In STN Viewer, these activities include the ability to purchase CPlusSM or INPADOCDB Patent Family Information, and the ability to Display, Save, or Share document details for records added to patent projects from Patent Family Information displays.

c. For both STN AnaVist and STN Viewer, long term storage fees apply to projects associated with these Login IDs.

5. STN AnaVist users only:

a. STN Login IDs for Shared Projects may be used to download STN AnaVist software and to order STN AnaVist software on CD-ROM. Shared projects users are bound by the STN AnaVist License Agreement.

b. STN Login IDs for Shared Projects are designed to allow a user to interact with STN AnaVist projects prepared by others. These IDs do not allow a user to access the full power and functionality of STN AnaVist, e.g., users cannot create new visualizations or conduct new searches within STN AnaVist.

6. Other than STN AnaVist and STN Viewer, STN Login IDs for Shared Projects are not valid for use with any other STN product.
