2 New SELECT field " PRIORITY COUNTRY FIRST"

Two new SELECT fields are now available in INPADOCDB and INPAFAMDB which are useful for statistical analysis of first filing priorities. The field **PRCF** identifies the country of the first priority, and **PRCF.WO** can be used to identify the country where the first PCT priority was filed. In the case where more than one priority is used with the same priority date, only the first country found by the system was used for PRCF.
